The lead author submitting the abstract must provide complete contact details: mailing address, phone, fax, e-mail etc. At least one author of an accepted paper must pay the registration fee and attend the conference.

Authors will be notified by June 5th, 2007, of their paper status. Authors whose abstracts are accepted will have to register and submit their full-length papers before August 5th, 2007. Quality papers among accepted ones would be printed as a special issue of an international journal or a special volume. While multiple submissions by individual or groups of authors are welcome, the abstract selection process will seek to ensure as broad participation as possible: each speaker is to deliver only one presentation in the conference.
