## **The Fine Print**

- **You must make your tuition payment by September 30, 2018 for earlybird rates. Your tuition payment provides access to all educational programming offered and course material (for a single day in the daily option), lunches and coffee breaks, a farewell dinner, CPD credits (two-day full attendance required) and IAEE Certificate of Attendance.**
- **A limited room block has been reserved at the on-campus guesthouse "Bebek Gate House" for accommodation and will be allocated on a FCFS basis. If there is no availability at the time of registration, only tuition will be charged on your credit card and alternative hotel recommendations (more expensive) will be provided.**
- **Cancellations are allowed if requests are received on or before October 12, 2018 (ten days before the Summer School begins), but is subject to a non-refundable €200 administrative fee. Requests for cancellations received after October 1, 2018 will not be honored; and in such cases no refund can be made from the original registration fee, nor is any refund allowed for no-shows. There are no exceptions to this policy. Should you be unable to attend, however, a substitution may be made to transfer your fully paid tuition to another member of your organization at anytime up to October 21, 2018**
