5. Requirement to Provide an Executive Summary. Within thirty days of notification that this paper has been accepted for publication, the Author agrees to write and submit a short (1 to 2 page) *non-technical* Executive Summary of this article which highlights the following: why the Author wrote the paper, a short account of the research performed, and a statement of the conclusions of the research summarizing the outcomes and benefits of the work. the initial print of the composed article to be published by IAEE. The Author acknowledges that failure to provide the Executive Summary will result in the article not being published by IAEE. The abstract will be posted on IAEE's website in advance of the official publication date of the issue of *Economics of Energy & Environmental Policy* that carries the Article.

6. Copyright, Open-Access, Creative Commons Licensure, and Derivative Works Election.
