5. Requirement to Provide an Executive Summary. Within thirty days of notification that this paper has been accepted for publication, the Author agrees to write and submit a short (1 to 2 page) *non-technical* Executive Summary of this article which highlights the following: why the Author wrote the paper, a short account of the research performed, and a statement of the conclusions of the research summarizing the outcomes and benefits of the work. The Author agrees that no tables, charts, graphics, equations, etc. are to be included in this Executive Summary. The Author agrees that the Executive Summary will be sent to *The Energy Journal's* Editorial Office (EnergyJournal@iaee.org) no later than 30 days after the Author receives the initial print of the composed article to be published by IAEE. The Author acknowledges that failure to provide the Executive Summary will result in the article not being published by IAEE.

The abstract will be posted on IAEE's website in advance of the official publication date of the issue of *The Energy Journal* that carries the Article.

6. Copyright, Open-Access, Creative Commons Licensure, and Derivative Works Election. If he or she elects publication under the Green Open-Access Policy, the Author agrees to assign to the IAEE the copyright and all rights under it for an embargo period of three years from the date of publication of the article, after which the copyright shall revert to the Author. If he or she makes an election to publish the article pursuant to the Gold Open-Access policy, the Author shall retain the copyright to his work.
