In consideration of he IRAEE Conference in Tehran, 25-27 May 2004:

Firstly, our newsletter **EEnergy Informe**, is pleased to be a media sponsor for the IRAEE Conference in Tehran. We have already communicated with you, **Mr. Farmand** and others on this issue. #### International experience in electricity market reform: What's the right course for Iran?

#### Abstract

Since early 1990s, a number of countries around the world have embarked on restructuring, privatization, and liberalization of their electric power sector. The experience of these experiments, however, have been decidedly mixed.

In some cases, the results have been significantly lower costs, improved operational efficiencies, better customer service, more rational organizations, and more accountable management. These markets tend to be well-designed and well-functioning, resulting in viable competition among market participants. England and Wales and the Nordic countries are generally regarded among successful experiments.

In some cases, the original design of the market had significant flaws, has been poorly timed, or was not well-implemented resulting in unacceptable outcomes. In a few cases, the restructuring experiment resulted in significantly higher prices and/or unacceptable price volatility. A few notable examples of market failures include California and the Province of Ontario in Canada.

In other cases, the resulting restructured and/or privatized markets have produced other problems, such as inadequate investment in the sector. Examples include several Latin American countries.

This paper summarizes the useful lessons which may be learned from both successful and failed markets and poses the question "What's the right course for Iran?"
